

Trade Up to Toro Terms and Conditions – Cash Payment (Mastercard)

1. The Trade Up to Toro is the offer by the Promoter of a gift of up to £75 (the “Gift”) to purchasers on purchases of selected Toro models. Claims are valid for purchases made between March 15th 2024 and July 31st 2024 and for which the Promoter has received a completed and valid claim by August 31st 2024.
2. Claims will be paid via a prepaid Mastercard®. There is no cash alternative for this promotion.
3. No other offers can be claimed in conjunction with the Promotion.

 - c. If a serial number cannot be provided at the time of the claim because the product has not been delivered, please state when the delivery is expected and complete the claim after delivery has taken place and before August 31st 2024.

 - e. A picture of the model and serial number plate of the product(s) purchased must be provided for claim forms.

In addition, the Promoter reserves the right to reject those claims which are, in their opinion, fraudulent or invalid. 15. Claimants should allow up to 30 days from date of claim approval for receipt of the redemption email and code allowing you to select either a physical or virtual prepaid Mastercard.
16. A virtual Mastercard can only be claimed when a valid email address is provided on the claim form. All online claims will require an email address to be entered before submitting a claim.
17. Once claim approval has been confirmed by the promoter, you will be sent an email to access your prepaid Mastercard redemption code within 30 days. Once received, you will have 90 days from the date on this email to redeem your code. If you do not redeem your code selecting your preferred choice of Mastercard within this 90 day period, the link will expire and you will no longer be eligible for the Gift.
18. The prepaid Mastercard is valid for 1 year after redemption. Please pay close attention to your individual expiry date. All available funds must be redeemed by this date. If not redeemed the funds will be lost and cannot be reinstated.
